2. Learning Outcomes

Learning Outcomes

The course highlights the creative act and artistic practice as methodological tools of research aiming at the production of new work. Research based on artistic practice is applied here to questions about the produced work.

Learning outcomes

1. Development of critical thinking and technical skills along with the development of practical skills.
2. Linking research into interdisciplinary resources with methodical analysis and interpretation of the work produced.
3. Developing elements of project planning and implementation.
4. Creative initiative as a means of analytical and critical thinking.

3. Course Content

The course focuses on practice and applied research as creative tools for the production of original work. It explores the starting points of artistic research, their multiple inscriptions in the production of drafts and projects that feedback to, describe, explore and discover new resources for research and creation. The process of research through documentation, observation, and gathering of experience in general, as well as the performative act, define part of empirical research and intuitive knowledge. The workshop completes the shift from research and creation to inferential knowledge and critical awareness. The course is structured as a series of hands-on assignments, readings and short-form written exercises common to everyone, before each student's personal areas of interest are pursued.

Indicative topics:

- Materiality: (a) tactility (b) performativity (c) composite and hybrid materialities (d) politics and aesthetics of materials (e) dematerialization
- techniques and skills: (a) transcription of techniques (b) fragmentation and 'choreography' of practice (c) craftsmanship and its failures
- economics: (a) targeting (b) management and production methods (c) sources of materials and images (d) social and economic factors.

Tropes and methods:

- Essay-works as responses to an artwork.
- Art installations - arrays and interconnections.
- The work as research - research as work.
- The work as feedback to the research process.
- The work as a way of transmitting research.
- The afterlife of the work, recording and documentation.
